Themed eatery to make its debut on the iconic Galveston Island Historic Pleasure Pier

HOUSTON, TX (January 30, 2012) - Galveston will soon join the ranks of great tourist destinations such as the Santa Monica Pier, Navy Pier and Times Square all who boast Bubba Gump Shrimp Co.
